3. Term

- 3.1 The term of this memorandum shall be five (5) years commencing on 01/01/2019 and expiring on the 31/12/2025 unless otherwise agreed or extend by the Party in writing.
- 3.2 The term shall be reviewed by the Party not more than twelve (12) months and not less than six (6) months prior to the expiration of the term subject to the term being reviewed prior to this period.
